- a. Keith Martin asked if the RAC would be hosting ICS 400 soon. TEEX has a session scheduled in Jacksonville on August 5th and 6th. Per Mark Weaver (TEEX ICS instructor), ICS 300 and 400 will be held in the City of Whitehouse in early 2026. If there is a need for at least 25 people a request can be made to host a class in the fall in Tyler. Otherwise, due to poor attendance and registration in FY25, the RAC will continue to coordinate with TEEX and promote local courses already scheduled in the region.
- b. Kenneth Webb asked if HPP could provide the SAMA instructors course for de-escalation training. Eric Bailey stated HPP staff will look into the requirements and cost and follow up in the next quarterly meeting.
- c. A local trauma coordinator requested RAC assistance finding a trainer to present disaster triage training to ER staff. None of the hospital representatives in the meeting knew of any standard training protocols or education of this kind in their facilities but stated they think it would be beneficial to look into. Lisa Modisette will follow-up on the results with the requesting facility and work to implement ER disaster triage training regionally.
