In the new Trauma Rules on September 1st, 2025 all hospitals must place wristband numbers/information within the medical record. This is an item that will be checked during your designation or re-designation process, and tied to funding. Thus we need to train the hospitals as to why, and where to record this information. Also note we as a PHC/AMC set a date for applying wristbands to patients no later than July 1st 2025. This wristband rule is not currently in place in the DSHS EMS rules as of this time, but it is coming soon. RAC office has plenty of bands for each organization. Side note: on the Tuesday before GETAC the Whole Blood Task Force with have a luncheon where many of our questions may be answered. People were encouraged to attend and learn.
