### STROKE

#### 1. GETAC Updates

- a. The following have been approved by all appropriate committees as well as the GETAC Council.
  - i. Prehospital Adult Stroke Routing and Resource Document
  - ii. Prehospital Pediatric Stroke Routing Algorithm

- b. Discussion was conducted among the committee to see if we could take the Pediatric Algorithm and edit it for our RAC-G resources. Shawn mentioned that once it has been updated it needs to go through EMS, Air Medical and Pediatric Committee for review and recommendations. It was also mentioned that the RAC-G needs to determine what we define as pediatric versus adult to help simplify things. Jennifer will start working on this and prepare to send out for review to continue discussion on this at our next meeting.

2. Review data from RDC and discuss.

- a. Discussion was had that we are still struggling to get all facilities within RAC-G submitting data to the RDC. It was discussed to have communication sent to the entities not currently participating urging them to start submitting data. Members of the committee agreed this was needed as their leadership is apprehensive to do this without hearing directly from the RAC-G on this. Action item: Jennifer will send an email to the RAC-G office to see if communication can be sent out to the leaders of the entities not currently submitting data at this time.
- b. Jennifer and Aaron had numerous discussions regarding concerns with RDC not pulling data as it should. We have reached out to the RDC to help investigate this as well.

3. Review proposed transfer document with edits from last meeting.

- a. The committee approved the document with the recommended additions from the last meeting. Everyone was excited to have this resource to help when sending stroke patients out to the CSCs. Action item: Jennifer will send it to the RAC-G office to get posted to the website and email out to committee members.

4. Review proposed RAC-G Code Stroke Recommendation.
  - a. Lisa mentioned that this should be used as a resource or reference document as some facilities use different terminology. Jennifer mentioned that she would send to Lisa for her to mark up and then would condense it into one document to bring back to the committee next meeting. Action item: Send the Code Stroke Process and Workflow documents to Lisa Hutchison for edits from her health system perspective.

  - a. Request was made for the Stroke Committee to create recommendations for OB Code Stroke procedures.
